Re: Right-to-Know Law Request No. 5310-09-006

Dear Mr. Mutchler,

As indicated in the May 21, 2009 denial, I have made this request before. I am now writing a brief explanation as to the reason for my determination in acquiring this record.

I live less than one mile from the A/C Fuel Coal Fly Ash Dump. This dump contains roughly 1,000,000 cubic yards of toxic waste.

My RTKL request No. 5310-09-006 was clear and to the point. The A/C Fuels fly ash dump represents over 1,000,000 cubic yards of toxic industrial waste and has an "entity that manages and/or owns A/C Fuels".

I am objecting to my current denial by Thomas Callaghan, P.G. and the PA DEP because it contains conflicting statements:

1. The May 21, 2009 denial states that the department does not have my record and that it would be illegal to create a document for the purposes of fulfilling my RTKL request.
2. The next paragraph states that the record that is unavailable in paragraph (1) is now denied because I have not been clear and that the department is somehow confused about my request. I have made my request abundantly clear, there was no misunderstanding.
3. The third paragraph denies my request because I have requested this information since 2003. This is a lie meant to discredit my true intentions. I have made repeated RTKL requests about the illegal blasting investigation conducted by DEP since 2003; my RTKL requests about the coal fly ash dumps have only been made since November of 2004. The current denial has only recently been made.

I am requesting a clarification of my denial of RTKL request No. 5310-09-006. If my petition is granted then I am requesting the amended denial sent in the form of an affidavit signed by Thomas Callaghan, P.G.

I allege that Keith B.C. Brady, P.G.; Randy Shustack, SMCi Supervisor and Thomas Callaghan, PG District Mining Manager with government corruption, fraud and conspiracy to obstruct justice in connection with this investigation.
